Dear Commercial Fryer Manufacturer or Other Interested Party:

EPA welcomes your input on the following **Draft 2** specification for ENERGY STAR<sup>®</sup> qualified Commercial Fryers. This document represents EPA's final Draft proposal for the criteria and testing procedures that manufacturers will need to abide by in order to qualify products as ENERGY STAR.

On behalf of EPA, I would like to thank everyone for reviewing and providing comments on the Draft 1 specification. These comments were of great assistance in modifying the specification for the Draft 2 release. Throughout the document, the note boxes have been updated to address specific industry comments and concerns and provide EPA's rationale behind making revisions to the Draft 1 version.

Specifically, the Draft 2 specification incorporates the following changes:

- The maximum idle rate for electric fryers has been increased to 1000 watts.
- The maximum idle rate for gas fryers has been increased to 9,000 Btuh/hr.

The Draft 2 specification proposes an August 15, 2003 effective date, in which partners may begin qualifying and labeling their products as ENERGY STAR. **To meet this effective date, EPA must receive all final comments on the Draft 2 specification by July 30, 2003.** Comments should be sent to Rebecca Miller, ICF Consulting, via e-mail at [rmiller@icfconsulting.com](mailto:rmiller@icfconsulting.com). All written comments will be posted on the ENERGY STAR Web site for review, unless the submitter indicates otherwise. If no additional comments are received, EPA will assume that stakeholders support/concur with the Draft 2 specification.

Once all final comments have been collected and reviewed by EPA, a Final Version 1.0 specification will be issued as part of EPA's Partnership Agreement, which also provides additional information for potential partners such as the ENERGY STAR Identity Guidelines and Qualified Product Information (QPI) Forms. **EPA hopes to announce an ENERGY STAR Commercial Fryers Specification at the NAFEM Show, September 5-7, 2003.** EPA will work closely with partners to complete all necessary documentation prior to the NAFEM Show product launch.

Thank you for taking the time to review the Draft 2 specification. The exchange of ideas and information among EPA, industry, and other interested parties is critical to the success of ENERGY STAR.
