

## Proposed Recognition Criteria Refrigerator-Freezers and Freezers

## Scope

*Included products:* Refrigerator-freezers and freezers are eligible for ENERGY STAR® Most Efficient recognition in 2021.

Excluded products: The following products are not eligible for ENERGY STAR Most Efficient recognition in 2021:

• All-refrigerators. At the present time, standard-size all-refrigerators are not eligible for ENERGY STAR Most Efficient 2021 recognition.

## **Recognition Criteria**

- 1) Product must be ENERGY STAR certified consistent with applicable ENERGY STAR Partner Commitments and the requirements set forth in the ENERGY STAR Program Requirements Product Specification for Residential Refrigerators and Freezers, Version 5.0. Product performance must be certified by a certification body recognized by the U.S. Environmental Protection Agency (EPA).
- 2) For standard-size refrigerator-freezers and freezers, product must have an Annual Energy Consumption (AEC) of less than or equal to 637 kWh per year.
- 3) For standard-size refrigerator-freezers other than top freezers<sup>1</sup>, product must be at least 20% more efficient than federal requirements (see table below), as determined by the DOE test procedure in 10 CFR 430 Subpart B, Appendix A. For standard-size and compact freezers, product must be at least 15% (standard-size) or 20% (compact) more efficient than federal requirements, as determined by the DOE test procedure in 10 CFR 430 Subpart B, Appendix B. For compact refrigerators and refrigerator-freezers, product must be at least 25% more efficient than federal requirements, as determined by the DOE test procedure in 10 CFR 430 Subpart B, Appendix A.

<sup>1</sup> Top freezers are not subject to part 3 of the Recognition Criteria; all ENERGY STAR certified top freezers that have an AEC less than or equal to 637 kWh per year are eligible for ENERGY STAR Most Efficient recognition.

## **Recognition Period**

EPA will add eligible models to the ENERGY STAR Most Efficient 2021 product list for refrigerators from January 1, 2021 through December 31, 2021. The ENERGY STAR Most Efficient 2021 designation may be used in association with models recognized during this period for as long as the model remains on the market.
