## **Final Draft Version 2.0 Timeline**

Stakeholders will have an opportunity to comment on the Version 2.0 specification prior to finalization, which is scheduled for June 1, 2012. Based on this schedule, the new Version 2.0 will go into effect on March 1, 2013.
