The Future of HPwES - We Need Your Feedback!

As part of our effort to continually improve Home Performance with ENERGY STAR, we are considering several program changes. The changes under consideration would align HPwES closely with Gold Star requirements in the *proposed* Home Star legislation. EPA believes these changes are needed to differentiate the program in the future and to meet the opportunity that Home Star would create. Changes being considered include:

- Establishing a minimum total energy savings threshold of 20%, as identified through the use of approved building simulations software
- Establish minimum technical criteria for workers/building scientists
- Establish minimum business criteria for participating contractors (e.g., quality management systems to record and track data, licenses, insurance)
- Create a new HPwES logo agreement for participating contractors
- Limiting program sponsorship to government entities, public utilities, or organizations designated by a state

We look forward to discussing these changes with you in the weeks ahead.
