ENERGY STAR® Labeled Products: Verification Testing
2014 Summary

In order to ensure that ENERGY STAR labeled products meet consumer performance expectations on an ongoing basis, a subset of models are subject to verification testing each year. This testing occurs through three complimentary programs, one of which is focused exclusively on lighting.

Verification Testing Rates

ENERGY STAR qualified products available for sale in the United States are subject to verification testing to ensure they continue to meet performance requirements. For the 2014 cycle, 2,070 models underwent verification testing. Of these:

- 1,933 models were tested through verification testing administered by EPA-recognized certification bodies (CBs). Further details on the verification testing process for CBs are available at www.energystar.gov/CBresources.
- 99 appliance, heating and cooling equipment, commercial food service equipment, and other models were tested through [U.S. Department of Energy \(DOE\)-administered verification testing](#).
- 38 compact fluorescent lamp (CFL) models were tested through the ENERGY STAR CFL Third Party Testing and Verification program. Detailed reports with test results from Batch 4 will be available at www.energystar.gov/integrity.

The overall compliance rate was 97%. [Table 1](#) provides a detailed summary of results.

Disqualification

ENERGY STAR qualified models that fail to meet ENERGY STAR requirements during verification testing are subject to EPA's [disqualification procedures](#). In 2014, EPA disqualified 58 *unique* models as a result of verification testing. Additional, separately-branded versions of the 58 models were also disqualified. [Table 2](#) summarizes the 58 unique disqualified models by product category.
