EPA Released the First Draft of ENERGY STAR Luminaires Specification V2.0

Released on December 17, 2014, the first draft ENERGY STAR Luminaires specification builds on the themes outlined in the [Discussion Document](#) released in October, focusing on streamlining the specification requirements, increasing efficacy levels to keep pace with new technology and capture greater energy savings and increasing flexibility to broaden the selection, customization, and availability of a wide variety of ENERGY STAR certified luminaires.



Some highlights include:

- An option for luminaires to use LED and CFL lamps certified to the ENERGY STAR Lamps Specification to support the majority of the testing required for certification of the luminaire
- Retrofit kit products for wall sconces and ceiling-mounted luminaires
- New criteria for connected luminaires
- Testing guidance for measuring color tunable luminaires

Brand Owners: Submit your 2014 Unit Shipments of ENERGY STAR Products no later than March 1, 2015

As a reminder, all partners with ENERGY STAR products certified in 2014 are required to report annually their certified product unit shipment data. EPA sent a notification to all partners with ENERGY STAR certified products on January 5, 2015. All ENERGY STAR partners must provide unit shipment data for all ENERGY STAR models certified under its ENERGY STAR partnership shipped to or within the United States from January 1, 2014 – December 31, 2014. Please submit all data to Unitshipmentdata@energystar.gov no later than March 1st, 2015.

EPA's unit shipment data webpage, www.energystar.gov/unitshipmentdata, provides the data collection process timeline, a link to Frequently Asked Questions (FAQs), data collection forms, EPA correspondence, and summary reports from previous years.

There is a Better Way to Find Model Numbers Using the ENERGY STAR Product Finder Tool

Energy Efficiency Program Implementers: Please note that EPA requires additional model numbers that are part of a product family certification to be listed on one line of the ENERGY STAR certified products list in the additional models field. You may use the [ENERGY STAR Product Finder](#) search tool to determine if a model is on the ENERGY STAR list. Alternatively, you may search both the model number and additional model information fields on the ENERGY STAR list. EPA has also provided an [excel macro](#) available on the [ENERGY STAR Product Finder homepage](#) under Resources. If you need help locating model information, please contact your ENERGY STAR Account Manager or email Lighting@energystar.gov.
