Dear ENERGY STAR[®] External Power Supply Partner or Other Interested Party:

Since 2002, EPA has been implementing the verification testing initiative, which supports our efforts to ensure that the program delivers on all of its energy-efficiency promises. Today, I am writing to inform you that external power supplies have been selected for testing.

Shortly, EPA will begin testing a sample of qualified external power supplies to verify compliance with the current ENERGY STAR specification. The goal of this testing initiative is to identify potential compliance problems and set in motion a review process to ensure Partners take corrective measures as appropriate.

Partners whose product(s) have been selected for testing will be notified soon in writing. The notification letter will indicate the model(s) selected and the time frame for testing. OnSpeX, an independent laboratory located in Atlanta, Georgia, will test the selected products.

Each model will be tested according to ENERGY STAR product testing guidelines. The guidelines for external power supplies may be found at <http://www.energystar.gov/library>. Under "Partner Resources by Partner Type" click on "Product Specifications" and then on "Program Requirements" to the right of "External Power Adapters."

Once testing is complete, Partners will receive written notification of the results for their products. Should a model fail to meet the ENERGY STAR specifications, the Partner will have 30 days to submit information based on its own test data to verify that the model is in compliance with the current specification. EPA will remove the model in question from the qualifying product list *only* if the Partner fails to adequately respond within the 30-day time frame, the Partner's test data does not fulfill the ENERGY STAR requirements, or the Partner acknowledges the product is mislabeled. The procedure for data submittal will be outlined in greater detail in a letter to all manufacturers with specific products under test.

In closing, it is important to note that ENERGY STAR will continue to be a self-certification program, although EPA requires third-party test data for some product categories and reserves the right to request additional test data on a case-by-case basis. This verification testing initiative does not replace industry-testing efforts; rather, it is designed to monitor the marketplace, protect EPA and Partner investments in ENERGY STAR, and ensure that consumer confidence in ENERGY STAR is never compromised.

Thank you for your continued cooperation and support of the ENERGY STAR verification testing initiative. We are committed to maintaining open communication and dialogue with manufacturers and their representatives throughout the testing process.
