Since the circuit system and technology, and development history are different, the power consumption of Blu ray player and DVD player is different in present technology. 2)HDMI and other input

The draft definition shows that it is for HDMI input product, only. Some product have legacy input such as RCA stereo and other analogue input also. We think we should consider such legacy input powers in definitions.
