The U.S. Environmental Protection Agency (EPA) is pleased to provide the **2020 ENERGY STAR[®] Summary of HVAC & Smart Thermostat** (Summary). The Summary provides an overview of a variety of programs offered by utilities and other energy efficiency program sponsors in the United States to promote ENERGY STAR certified commercial and residential heating, ventilation, and air conditioning (HVAC) equipment, including smart thermostats. The Summary includes information provided by energy efficiency program sponsors and describes their current program offerings in 2020-2021 and beyond.

Each ENERGY STAR HVAC and smart thermostat program is summarized with a focus on incentives (e.g., mail-in rebates, instant discounts), program contacts, and other relevant program details. Participation in the Summary is voluntary and therefore may not represent all promotions and incentives available across the country.

The information in this Program Summary is current as of July 1, 2020. More current or additional information may be available at www.energystar.gov/rebatefinder. The information provided in this program summary focuses on ENERGY STAR-branded programs, but Rebate Finder provides a more comprehensive list of incentives that are eligible for ENERGY STAR, but do not require ENERGY STAR-certified products.

Executive Summary

The 2020 ENERGY STAR Summary of HVAC & Smart Thermostat Programs (Summary) presents information submitted by 125 energy efficiency program sponsors from across the United States, including 7 “umbrella organizations” and statewide programs running promotions on behalf of or in conjunction with cooperative or municipal utilities and investor-owned utilities. Partners have provided information on 790 individual incentive and promotion programs for ENERGY STAR certified HVAC equipment and smart thermostats. To improve the accuracy of available promotions nationwide, information submitted under umbrella organizations has been accounted for individually for each member utility, unless otherwise indicated as a statewide or centrally administered program.

From the information submitted by energy efficiency program sponsors, the key highlights include:

Program Budgets – Partners were asked to categorize their HVAC and smart thermostat program budgets into buckets demonstrating order of magnitude and range (e.g., less than \$50K, \$50K - \$250K, \$1 - \$5 Million). To calculate state totals, the mid-point of each bucket for each partner was summed within the state. Since exact budget information has not been provided, nor have all partners given budget information (see the [HVAC & Smart Thermostat Budget Map](#) on page 4 for more details), a precise total cannot be determined. In 2020, based on the mid-point calculation, ENERGY STAR HVAC and smart thermostat programs were funded at just over \$120 million. This is up from \$80 million in 2019 and \$70 million in 2018, which was the first year this summary was developed. The large increase is attributed to New York’s initiative to install heat pump technology from 2020-2025, including ENERGY STAR geothermal heat pumps, which has a total budget of over \$600 million.

Promotions by Dollar Amount – Incentives in 2020 range from \$25 for smart thermostats to \$2,850 for geothermal heat pumps. The average incentive for central air conditioning units in 2020 is just over \$215 (representing a .5% decrease), while air-source heat pumps have an average incentive of \$357, which is a 17% increase from 2019. Smart thermostats have an average incentive of just under \$67, which is a 1% decrease. Geothermal heat pumps have the highest average incentive amount of just over \$1,050, which is a 40% increase compared to 2019, and boilers have the second highest average incentive amount of over \$500, representing a 44% increase from 2019. Ductless heating & cooling equipment has an average incentive amount of \$305 (a 6% increase) and furnaces have an incentive amount of over \$420 (a 12% increase from 2019). Promotions by Product – Similar to 2019, smart thermostats are the most popular incentive with 31% of all the HVAC & smart thermostat incentives in 2020, which is a 2% increase from 2019. Air-source heat pumps have the next largest portion for the total HVAC and smart thermostat incentives at 29%, followed by central air conditioners with 21% of all incentives, both of which saw a decrease compared to 2019. Geothermal heat pumps follow with 13% (a 1% increase from 2019) and then furnaces at 3%, which is the same as 2019. Boilers follow closely with 2%, representing a 1% increase from 2019, and ductless heating & cooling equipment have the lowest portion of total incentives at 1%, which is the same as 2019. Promotions by Type – Almost all the promotions—91%—are mail-in rebates, a decrease of 1% compared to 2019. HVAC and smart thermostat promotions with instant rebates, mid-stream rebates, online rebates, buy-down/discounts, and bill credits account for the rest. Smart thermostat incentives have more diversity for promotion types when looking at that category separately. In 2020, 74% of smart thermostat incentives are mail-in rebates, online rebates and instant rebates both represent 13%, followed by bill credits, which represent 3%. Promotions by Installation Criteria & Incentive Recipient – In 2020, ENERGY STAR requested additional information about intended recipients and installation requirements for incentives provided. Of the 785 incentives, 69% provided incentive recipient information and information on installation criteria. Of

the 544 responses for incentive recipient, 11 incentives were specified for distributors or dealers and the remainder were intended for customers. Partners were provided four options for installation criteria (self-install, contractor install – any mode, contractor install – specific list, and any mode of installation) and were asked to categorize each incentive. Of the responses, “any mode of installation” was the most popular installation criterion (38%), followed by contractor installation from any contractor (25%), and contractor installation from a specific list (4%). Only smart thermostats offered a self-installation option, accounting for 2% of all incentives. 
Promotions by Region – The Midwest region has the greatest number of ENERGY STAR certified HVAC and smart thermostat promotions with 587. The Midwest’s high number of promotions in comparison to other regions is largely due to the number of smaller cooperative and municipal utilities offering promotions for HVAC equipment and smart thermostats. The Mid-Atlantic region follows next with 62. The Northeast (40) and West (39) are the next regions with the most offerings. Followed up by the Southwest (29) and Southeast (24). Sector Trends – Program sponsors are focusing more on heat pump technology as they shift focus to decarbonization efforts, which includes the New York State Clean Heat initiative. This statewide initiative provides funds from New York utilities and the New York State Energy Research and Development Agency (NYSERDA) to offer large incentives of geothermal heat pumps. There was a 20% increase of geothermal heat pump incentives offered in 2020 (from 86 in 2019 to 104) offered on geothermal heat pumps from 2019 to 2020. This trend is expected to continue and will continue to be tracked in the 2021 update.

The map below shows program budgets for HVAC & smart thermostat programs by state as reported by the energy efficiency program sponsors.



National HVAC & Smart Thermostat Promotion Charts and Graphs






2020 ENERGY STAR HVAC & Smart Thermostat Promotions by Product Type
(Totals listed in parentheses)




ENERGY STAR and Energy-Efficient HVAC & Smart Thermostat Promotions by Product Type 2018-2020




2020 ENERGY STAR HVAC & Smart Thermostat Promotions by Incentive Type


2020 ENERGY STAR Smart Thermostat Promotion by Incentive Type
