Portfolio Manager allows you to strategically measure and manage your energy use to not only save energy but also reduce operating costs. By understanding your property's energy use, you can identify opportunities for cost-effective savings and investments.

Using Portfolio Manager is simple and straightforward with a clear online interface, password protected account, and ability for multiple users to securely share and report property information. To set up an account, your dealership just needs to enter basic information on the dealership like size, location, number of vehicles, and energy/water use. After that, you have access to dozens of useful metrics to inform you of how you're performing.

The 1 – 100 ENERGY STAR Score and Certification

To be certified as ENERGY STAR, a building must meet strict energy performance standards. ENERGY STAR developed the 1-100 ENERGY STAR score for vehicle dealerships using data collected by the National Automobile Dealers Association (NADA). The score measures the energy efficiency of a dealership relative to similar dealerships nationwide.

EPA's 1-100 ENERGY STAR score compares your dealership to similar dealerships nationwide, taking into account your building's size and operations. This apples-toapples comparison gives you a clear understanding of whether you are using energy more or less efficiently than your peers.

A score of 50 indicates median energy performance. A score of 75 indicates that a dealership is more energy efficient than 75% of similar dealerships nationwide and is eligible to earn the prestigious ENERGY STAR certification.

If your dealership scores a 75 or higher, it's easy to apply right in Portfolio Manager, then simply have your application verified and stamped by a licensed Professional Engineer or Registered Architect.
