Dear ENERGY STAR® Uninterruptible Power Supply Partner or Other Interested Stakeholder,

The U.S. Environmental Protection Agency (EPA) welcomes your input on the attached Draft 2, ENERGY STAR Version 2.0 Uninterruptible Power Supply (UPS) specification and revised draft test method. Stakeholders are encouraged to submit comments on these proposals to EPA no later than October 20, 2017.

The Draft 2 specification was developed based on comments received on the Draft 1 specification as well as subsequent discussions and research. The following key changes were made in this draft:

UPS Energy Efficiency Criteria

EPA worked with multiple stakeholders to increase the robustness of its estimate of ENERGY STAR UPS market penetration and in consideration of this additional information, has revised the Draft 1 efficiency levels. Recognizing that the EPA dataset does not represent the performance of numerous products on the market today, the Agency evaluated multiple scenarios when assessing the proposed levels that considered a range of efficiency performance for today's products and the impact of measurement uncertainty. EPA also factored in the Department of Energy (DOE) minimum efficiency final rule. Considering each of these variables, EPA is proposing levels that would recognize roughly the top quartile of the market.

Test Method

EPA has made edits to the ENERGY STAR test method to clarify testing accuracy, humidity, and updated references to Alliance for Telecommunications Industry Solutions (ATIS) standards. These changes do not apply to those products within the scope of the DOE test procedure.

<u>Other</u>

In addition, EPA made changes to the definitions and scope sections relating to Voltage Independent (VI) and Hybrid UPSs, respectively.

Comment Submittal

EPA welcomes stakeholder input on the attached Draft 2, Version 2.0 specification and the Draft 2 test method. Stakeholders are encouraged to submit any comments to ups@energystar.gov by October 20, 2017. All comments will be posted to the ENERGY STAR Product Development website unless the submitter requests otherwise.
