Dear ENERGY STAR® Commercial Refrigerator and Freezer Manufacturer or Other Interested Party:

With this letter, the U.S. Environmental Protection Agency (EPA) is pleased to share the Draft 1 Version 4.0 ENERGY STAR Commercial Refrigerator and Freezer specification. Stakeholders are encouraged to submit comments to EPA no later than April 19, 2016.

Given the U.S. Department of Energy (DOE) minimum federal standards were revised and have an effective date of March 27, 2017, EPA is proposing new ENERGY STAR performance levels for commercial refrigeration equipment (CRE). EPA believes the efficiency criteria proposed in this Draft 1 specification will offer significant energy savings and better differentiation relative to standard products in the marketplace.

The primary objectives of this revision are to: 1) lower the maximum daily energy consumption (MDEC) performance criteria levels, and 2) amend the applicable terms and definitions to align with DOE's Final Rule for CRE. Changes are highlighted in the note boxes throughout the draft specification. Key Elements of the Draft 1 Version 4.0 include:

Definitions

In accordance with DOE's final rule, EPA amended and added several terms and definitions relevant to this specification.

Revised Certification Criteria

This draft specification includes proposed MDEC levels based on a dataset of nearly 700 models and identifies a few available pathways to achieving increased efficiency of CRE, including enhanced efficiency lighting, improved insulation, and the incorporation of alternative refrigerants. The scope of this Draft 1 specification remains unchanged from Version 3.0. As such, commercial vertical and horizontal, self-contained refrigerators and freezers continue to be eligible for ENERGY STAR certification.


Stakeholder Webinar to Discuss Draft 1
