Lighting Industry Request for Proposals (RFPs)

Several EEPS now offer funding for cooperative promotions throughout the year to lighting manufacturers and retailers. RFPs that are active or expected in 2005 include:

Pacific Gas and Electric Company, San Diego Gas & Electric Company, and Southern California Edison Company sponsor the 2005 California IOU Residential ENERGY STAR Lighting Incentive Program. The program features manufacturer incentives for targeted ENERGY STAR qualified lighting products. Northeast

The **Northeast ENERGY STAR Lighting & Appliances Initiative** has distributed the 2005 Northeast ENERGY STAR Lighting Initiative Negotiated Cooperative Promotion (NCP) Request for Proposals (RFP) and closed the process in March. The 2005 NCP covered all qualified lighting products (fixtures, compact fluorescent light bulbs, and ceiling fans with light kits) and offers retailers and manufacturers cooperative funding for joint lighting activities including rebates, special events, product buy downs, cooperative advertising, and additional programs. Sponsors of this year's NCP include **Cape Light Compact, Connecticut Light & Power, Efficiency Vermont, Massachusetts Electric, Nantucket Electric, Narragansett Electric, NSTAR Electric, The United Illuminating Company, Unital, and Western Massachusetts Electric**. The Northeast expects similar activity in 2006.

The **New York State Energy Research & Development Authority (NYSERDA)** is offering funding for approved special projects to retailers and manufacturers that are

partners through the New York ENERGY STAR Products Program. These special funding opportunities are available for manufacturers and retail stores that educate consumers about ENERGY STAR qualified CFLs, fixtures and ceiling fans (with and without light kits). CONSUMER AND RETAIL-BASED PROGRAMS

The programs detailed in this section include those efforts to educate consumers on the benefits of ENERGY STAR qualified lighting through retail channels. Retailer Training and Field Support

Many Energy Efficiency Program Sponsors (EEPS) actively promote ENERGY STAR qualified lighting to local retailers. Field representatives often provide training on ENERGY STAR qualified lighting, help display point of purchase materials, discuss co-marketing opportunities, and disseminate information on program incentives available to customers.
